Message from the Executive Director



The sexual and reproductive rights of women with disabilities is an important issue that requires attention. When it comes to sexual and reproductive health and rights (SRHR), women and girls with disabilities are the least likely to enjoy these. The barriers that women and girls with disabilities face to fulfilling sexual and reproductive health

and rights are further compounded by the variety and intensity of their disabilities; the more, severe the disability the greater the risk of exclusion. Each type of disability creates specific needs around which SRHR services and information must be tailored, meaning there is no one-size-fits-all approach to guaranteeing the realization of their SRHR. However, attention to these needs is rare, rendering the entire spectrum of sexual and reproductive health services inaccessible to women and girls with disabilities.

Several factors and norms that are discriminatory are continually upheld by families and communities. Healthcare providers instead on helping matters for our women, poses even more challenges that put us at greater risk of exclusion and higher mortality rate. Challenges in accessing healthcare services inclusive of accessible information, maternal health, reproductive health inclusive of family planning, etc are often encountered by women with disabilities on daily basis in Nigeria. Although the advocacy is currently gaining momentum to create awareness, a lot of work is needed in the area. Reason Voice of Disability Initiative (VDI) prioritizes raising awareness on the underlying issues and challenges faced by women and girls with disabilities, offers good practices in this area, as well as call stakeholders to action to advance the recognition and realization of these sexual and reproductive health and rights.

Women and girls with disabilities have the same sexual and reproductive health and rights as other girls and young women, as recognised in the Convention on the Rights of the Child (CRC), the Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW), and the Convention on the Rights of Persons with Disabilities (CRPD), as well as in other international policy documents, including the Programme of Action of the International Conference on Population Development.

We further recognize the significant role of sanitation, water and hygiene (WASH) in sexual and reproductive health rights service delivery and realization to reduce health risks on our women and girls with disabilities in the areas of prevention and control of exposure to infections, healthy menstrual health, confronting harmful WASH related gender practices that affects SRHRs among others.

Consequently, VDI has been able to navigate the intersection from SRHR to WASH in the past months through series of project and activities implementation in partnership with other stakeholders, in pursuance of our mandate to advance the rights of women and girls with disabilities and confront harmful gender norms and other forms of GBV against our women as captured in this newsletter. With this I welcome you to the second edition of Voice of Disability Initiative Newsletter.

VDI Explores Collaboration Opportunities with NAPTIP

ongoing project focused on improving access to Sexual and Reproductive Health rights for women with disabilities, generously supported by AmplifyChange.

During the engaging discussions, both parties delved into various areas of potential collaboration. Key topics included the Sexual and Reproductive Health rights of women with disabilities, raising awareness and sensitization on Gender-Based Violence affecting women and girls with disabilities, combating child trafficking, and advocating for the implementation of Violence Against Persons Prohibition (VAPP) Laws in special schools. By engaging with key stakeholders like the FMOJ, VDI seeks to leverage collective efforts in addressing pertinent issues surrounding disability rights, legal frameworks, and access to justice.

During the productive meeting, Barr Gbola-Awopetu highlighted the difficulties in interpreting legal terminologies to a deaf while in court and also sought for support in the areas of basic sign language trainings as this will also make justice easily accessible to all especially the deaf and hard of hearing. both parties exchanged insights and perspectives on various aspects related to disability rights and legal advocacy. VDI had the opportunity to familiarize itself with the functions and initiatives of the FMOJ, while also highlighting its own ongoing projects and advocacy efforts. This interaction laid the groundwork for future collaboration aimed at enhancing the legal and social inclusion of persons with disabilities within the justice system.

As an organization dedicated to championing the rights of persons with disabilities, VDI recognizes the pivotal role that partnerships play in effecting positive change. VDI Strengthens Partnership with NHRC to Champion Disability Rights



Voice of Disability Initiative (VDI) recently embarked on a meaningful visit to the National Human Rights Commission (NHRC) with the aim of fostering collaboration and mutual understanding between the two organizations. Led by the esteemed Executive Director, Barrister Edeh, the VDI team was warmly received

by Director Obinna Nwankonye and his dedicated team on behalf of the Executive Secretary.

During the visit, Director Nwankonye highlighted the significance of such engagements in broadening the scope of the commission's work. This sentiment was echoed by Dr. Edward Ogenyi, VDI's Programs Manager, who emphasized the shared vision between VDI, a woman-led rights-based organization, and NHRC, a government agency tasked with coordinating rights-based matters, particularly for vulnerable populations.

The purpose of the meeting was twofold: to acquaint NHRC with VDI's mandate and to explore potential areas of collaboration.

Barrister Edeh highlighted the impact of NHRC's efforts nationwide, citing examples of increased accessibility for people with disabilities in higher education, including the field of law. She commended NHRC's commitment to inclusion, evident in its employment practices, which align with VDI's mission of promoting equal opportunities for all.

Discussions centred on:

- 1. Advocacy for the rights of persons with disabilities Leveraging NHRC's authority and expertise to advocate for the rights and inclusion of persons with disabilities.
- 2. Collaborating on training programs aimed at sensitizing stakeholders, including law enforcement agencies and legal practitioners, on disability rights and inclusive practices.
- 3. Collaborative efforts to advocate for the implementation and enforcement of disability inclusive policies
- 4. Collaborating on research initiatives to gather data on the prevalence of human rights violations against persons with disabilities and inform evidence-based advocacy efforts.
- 5. Jointly organizing campaigns and events to raise awareness about disability rights issues, challenge stereotypes, and promote inclusive attitudes and behaviours in society.

Promoting Inclusive Healthcare: VDI's Visit to the Ministry of Health



On the 19th of March, Voice of Disability Initiative (VDI) embarked on a significant visit to the Ministry of Health, where they engaged in constructive discussions with Dr. John Ovuoraye, Director of GASHE, and Madam Adaeze Ike, SNO on Gender.

The focal point of the meeting was to explore avenues for coll-

aboration between VDI and the Ministry of Health, particularly in identifying and addressing barriers to healthcare access for persons with disabilities (PWDs). Discussions also delved into interventions and solutions aimed at enhancing healthcare services for PWDs and addressing their specific needs.

One of the key highlights of the discussion was the importance of adopting inclusive policies and practices within healthcare facilities to ensure equitable access to healthcare services for all individuals, regardless of disability status. Additionally, the meeting emphasized the need to address gender-specific healthcare needs of persons with disabilities, ensuring that healthcare services are tailored to meet their unique requirements.

On the 4th of April 2024, VDI had the privilege of paying a courtesy visit to the National Agency for the Control of AIDS (NACA) to build collaboration and address the intersectionality of disability and HIV/AIDS within Nigeria's public health framework.

The director of NACA, Mrs. Temitope Illori and her esteemed team warmly received VDI representatives.

During the courtesy visit, led by Executive Director Barrister Catherine, VDI outlined its purpose of familiarizing NACA with its work and exploring potential collaboration opportunities. Fruitful discussions ensued, focusing on advocating for the inclusion of disability perspectives in HIV/AIDS prevention, treatment, and support programs. Additionally, opportunities for partnership in raising awareness about HIV/AIDS among persons with disabilities (PWDs) were explored, alongside strategies to enhance their access to HIV/AIDS services and support across Nigeria.

The meeting served as a platform for meaningful dialogue, addressing barriers faced by PWDs in accessing HIV/AIDS services, such as stigma, discrimination, and physical accessibility. Best practices and innovative approaches were shared to ensure inclusive HIV/AIDS programming that caters to the diverse needs of PWDs. The gathering saw the presence of esteemed personalities, including VDI's Executive Director, Barrister Catherine Edeh, alongside other distinguished figures such as Barrister Florence Marcus, Barrister Toyin Falaiye, Barrister Dumi Prophen, and Barrister Calister Ugwuaneke. Notable figures like Queen Janet of Ability Plus TV, Ms Avir Akighir, and Ms Constance Nneka Onyemaechi, among others, graced the occasion with their presence.

During the session, participants engaged in a thorough evaluation of the implementation of the Discrimination Against Persons with Disability (Prohibition) Act 2018. They identified several challenges and issued calls to action, urging:

i. The Federal Ministry of Works & Housing, The Nigerian Institute of Quantity Surveyors, Surveyors Council of Nigeria, and Nigerian Institute of Estate Surveyors & Valuers to enforce accessibility standards for public structures, facilitate the modification of public buildings, and approve building plans in accordance with the provisions of the Act.

ii. The Federal Civil Service Commission, Office of the Head of Civil Service of the Federation, Federal Ministry of Labour and Employment, and other relevant agencies to monitor the fulfillment of the 5% employment quota for persons with disabilities, with specific attention to gender considerations such as allocating 3% of employment opportunities for women and 2% for men with disabilities.

ii. The Federal Civil Service Commission, Office of the Head of Civil Service of the Federation, Federal Ministry of Labour and Employment, and other relevant agencies to monitor the fulfillment of the 5% employment quota for persons with disabilities, with specific attention to gender considerations such as allocating 3% of employment opportunities for women and 2% for men with disabilities.

The session underscored the imperative for all government agencies at the federal and state levels, as well as inclusive of the private sector, to embrace and uphold the principles outlined in the Discrimination Against Persons with Disability (Prohibition) Act 2018, ensuring its comprehensive implementation

The Vice Chancellor, who explained that the visit reinforced the University's standing as a bastion of inclusive education, commended the group on its efforts.

Prof. Egbewole said that he was delighted that some distinguished alumni of the University of Ilorin were part of the visiting team as he welcomed them to the University.

Assuring VDI of the University's commitment, Prof. Egbewole pledged to partner with the organisation in executing the VDI programmes at the University of Horin and the larger Horin community.

He, however, advocated extension of collaboration to the Disability Law Advocate Project of the Faculty of Law and the Centre for Supportive Services of the University of Ilorin for better service delivery.

The Vice Chancellor highlighted the University's proactive stance towards changing the institution's Centre for Supportive Services for the Deaf to a more comprehensive Centre for Supportive Services for Persons with Disability

The UNILORIN's Chief Executive Officer said that the University is also forging a partnership with the Joint Admissions and Matriculation Board (JAMB) for the purpose of advancing inclusive education.

Prof. Egbewole reiterated the University's readiness to provide facilities that would assist students with disabilities during JAMB examinations.

Anticipating a fruitful collaboration, the Vice Chancellor expressed hope that the two-year stay of VDI in Ilorin would foster a stronger synergy between the organisation and the University of Ilorin as he said that such a relationship would solidify their joint commitment to inclusive education.

Earlier, the Executive Director of the Voice of Disability Initiative (VDI), Barr. Edeh Catherine, said that her team came to solicit for support of the Vice Chancellor and his management team in realising the group's mandates.

implementing a two years project (2023-2025) in Kwara State on the rights of persons living with disability especially women and girls, adding that the project will be funded by AMPLIFYCHANGE, a UK- based International development organization.

Barr. Catherine, who is a law graduate of the University of Ilorin, recalled the University's pioneering role in disability inclusion, breaking protocols to accommodate individuals with disabilities, even in professional courses like law and medicine.

Reflecting on her own experience, Barr, Catherine recalled that the University of Ilorin uniquely supported her pursuit of law despite her disability, unlike some other universities in Nigeria that often redeploy students living with disability to study special education

She said that the University of Ilorin is a beacon of hope and that as a product of both the University of Ilorin and Kwara State, VDI considers the University a potential beneficiary of grants.

The VDI Executive Director said that the grant, which originated from a UK-based organisation, focuses on projects in Enugu, Kwara, and Ebonyi States

Barr. Catherine noted that the group had previously spent 18 months in Enugu, observing varying levels of passion for inclusive disability initiatives across regions.

Before arriving in Ilorin, the VDI team was pleasantly surprised to find that Kwara state is one of Nigeria's leading States prioritising disability law, despite the law's pending implementation.

In the process of identifying stakeholders to support their cause, Barr. Catherine singled out the Vice Chancellor of the University of Ilorin, a Professor of Jurisprudence and International Law, as a passionate advocate for people with disabilities and the University itself.

Also speaking, the Programme Manager of the Voice of Disability Initiative (VDI), Mr Edward Ogenyi, expressed admiration for the University of Ilorin's

She said that the VDI would be inclusive programmes and its treatment of people with disabilities.

> Speaking about the success of the University's policies, Ogenyi highlighted the potential for other institutions to learn from the virtues embedded in UNILORIN's approach

> Mr Ogenyi explained that VDI has a two-year grant for its project as he emphasised the need to collaborate with key allies for success.

> Dr Ogungbade, a former Interpreter at the University and now a lecturer in the institution shared his personal connection to the initiative.

> Acknowledging Prof. Egbewole's contributions as a lecturer in the Faculty of Law, Dr Ogungbade highlighted jurisprudence as a crucial area of collaboration between VDI and UNILORIN as he noted that the focus is on ensuring that the University continues to play a pivotal role in implementing the disability law passed by the Kwara State House of Assembly.

VDI Advocates for the Passing of Disability Bill into Law in Ebonyi State



The push for a disability rights law in Ebonyi State has gained significant momentum as advocacy groups Voice of Disability Initiative (VDI) and the Ebonyi State chapter of the Joint National Association of Persons with Disabilities (JONAPWD) have urged the state government to enact the Disability Bill.

During a meeting with the Speaker of the Ebonyi State House of Assembly on December 1, 2023, Barrister Catherine Edeh, Executive Director of VDI, emphasized the importance of legal protections for people with disabilities. She pointed out that the ongoing two-year project in Ebonyi State, supported by AMPLIFYCHANGE, can only achieve its intended impact if there is a law safeguarding the rights of persons with disabilities.



Barr Edeh's appeal resonated with the Speaker, who assured a prompt legislative process for the bill. She stressed that advocacy and initiatives for disability rights are most effective when led by persons with disabilities (PWDs) themselves, embodying the principle of "Nothing About Us Without Us." This slogan Emphasize belief that policies and decisions affecting PWDs should not be made without their direct involvement and input.

This advocacy effort highlights the critical need for formal legal protections to ensure that persons with disabilities in Ebonyi State have their rights recognized and upheld. The passage of the Disability Bill would represent a significant step toward achieving equality and inclusion for the disabled community, empowering them to contribute fully to society.
